This AMENDMENT (“Amendment”) to the Services Agreement #2025-023 (“Original Contract”) is made and entered into effective the date of last signature below by and between the NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS, a Texas political subdivision and non-profit corporation, hereinafter referred to as “NCTCOG”, and

hereinafter referred to as “Service Provider”, (collectively, “the Parties”).

WHEREAS, the Parties entered into the Original Contract on **August 26, 2025**; and WHEREAS, Section 9.15 of the Original Contract allows for amendments; and

WHEREAS, the Parties agree to amend the Original Contract in accordance with the terms of the Original Contract, as well as the terms provided herein.

NOW, THEREFORE, in consideration of the mutual covenants expressed herein, NCTCOG and the Service Provider agree as follows:

Pursuant to Section 9.15 of the Original Contract and Section 5.10 of the Request for Proposals (“RFP”), titled *New Goods and Services*, the Parties agree to amend the Original Contract as follows:

1. Add the following within the scope of the Original Contract:

- a.** New AI Consulting Positions; and
 - b.** Additional concurrent streams and minutes for AvatarAI,
- All as set forth in Attachment A, attached hereto and incorporated by reference.

2. Revisions to Existing Pricing and Conditions

Certain pricing, terms, and conditions set forth in the Original Contract are hereby revised, as more fully described in Attachment A, attached hereto and incorporated by reference.

The revised pricing and conditions shall supersede and replace the corresponding provisions of the Original Contract only to the extent expressly identified in Attachment A.

3. Removal of AI Translate

The Parties agree that AI Translate is hereby removed in its entirety from the scope of Agreement #2025 023. Effective as of the date of this Amendment:

AI Translate is not authorized for offering, marketing, or delivery under Agreement #2025 023;
Any prior inclusion of AI Translate shall be considered superseded and of no further force or effect.

This Amendment binds and benefits both Parties and any successors or assigns. This document, including the Original Contract, is the entire agreement between the Parties.

Except as expressly amended herein and in Attachment A, all other terms, conditions, and provisions of the Original Contract remain unchanged and in full force and effect.
