This AMENDMENT (“Amendment”) to the Services Agreement #2025-018 (“Original Contract”) is made and entered into effective the date of last signature below by and between the NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS, a Texas political subdivision and non-profit corporation, hereinafter referred to as “NCTCOG”, and

hereinafter referred to as “Service Provider”, (collectively, “the Parties”).

WHEREAS, the Parties entered into the Original Contract on **June 9, 2025**; and

WHEREAS, Section 9.15 of the Original Contract allows for amendments; and

WHEREAS, Section 5.10 of RFP # 2025-018, titled *New Goods and Services*, permits the addition of new AI solutions within the scope of the awarded contract; and

WHEREAS, the Parties desire to clarify and amend the Original Contract solely to add certain AI solution offerings, and to remove any solutions or references inadvertently associated with RFP #2025-023 (AI Consultancy Services).

NOW, THEREFORE, in consideration of the mutual covenants expressed herein, the Parties agree as follows:

1. Addition of New AI Solutions

Pursuant to Section 9.15 of the Original Contract and Section 5.10 of RFP # 2025-018, the Parties agree to amend the Original Contract to add the following AI solutions, as further described in **Attachment A** to the Original Contract:

- AttackAI
- CouncilAI
- RenderAI
- VoiceAI-

2. Transfer and Inclusion of TranslateAI

For clarity and avoidance of doubt, the Parties expressly acknowledge and agree that:

- TranslateAI was previously included under Agreement #2025-023 (AI Consultancy Services);
- Effective as of this Amendment, TranslateAI is removed from Agreement #2025-023 and shall no longer be offered, marketed, or delivered under that contract; and
- TranslateAI is hereby added to and included within Agreement #2025-018 as an authorized AI Solution, subject to the terms, conditions, and scope of RFP #2025-018, and as further described in Attachment A to the Original Contract.

TranslateAI shall be treated as an AI solution for deployment and operational use and not as an AI consultancy, advisory, planning, or training service. Any reference to TranslateAI under Agreement #2025-023 is superseded and of no further force or effect as of the effective date of this Amendment.

For clarity, the Contractor may offer, brand, market, and deliver goods and services under its legal name or under one or more registered trade names, product names, or solution brands, provided that such goods and services are delivered by the Contractor identified in the Original Contract.

This Amendment binds and benefits both Parties and any successors or assigns. This document, including the Original Contract, is the entire agreement between the Parties.

Except as expressly amended herein and in Attachment A, all other terms, conditions, and provisions of the Original Contract remain unchanged and in full force and effect.
